



FARM TIRE WARRANTY (LIMITED WARRANTY)

The Les Schwab Farm Tire Warranty (Limited Warranty) is provided for free as part of **Les Schwab's World Class Customer Service** and is valid for the original purchaser of the farm tires listed on the attached original invoice (farm tire). The Les Schwab Farm Tire Warranty (Limited Warranty) includes:

WORKMANSHIP, MANUFACTURE OR MATERIALS

Our workmanship is guaranteed for the life of your farm tire. Should a farm tire fail due to defects in manufacture or materials, we will provide you with an adjustment based on the lesser of the (a) remaining tread depth or (b) the life of the farm tire (as shown in the chart). All adjustments will be based on the original purchase price, including tax, multiplied by a percentage (as shown in the chart). Service and repair work required to adjust a farm tire may be charged according to our Fleet Service and Repair prices. You may elect to receive an adjustment in the form of cash or a credit applied to the purchase of new tires at any Les Schwab Tire Center. Adjustments based on the life of the farm tire are calculated from the date of the applicable invoice, as follows:

FIELD HAZARD PROTECTION

We will repair or replace your farm tire if it fails due to normal field hazards, subject to the following time limitations:

1. Rear Farm Tractor Tires: 24 months
2. Front Farm Tractor and Implement Tires: 12 months

WHAT IS NOT COVERED BY THIS LIMITED WARRANTY: This Limited Warranty extends to the farm tire used solely for agricultural purposes. This Limited Warranty does not cover services, damage or wear due to any of the following: use for logging, industrial or competitive purposes, or other misuse or abuse, including without limitation, a farm tire that has been run flat.

LIMITATION ON YOUR REMEDIES: In no event will Les Schwab have any liability to you in contract, tort or otherwise for any claimed incidental or consequential damages of any type whatsoever, arising in any way from breach of this Limited Warranty. Some states do not allow the exclusion of incidental or consequential damages, so these limitations may not apply to you.

EXCLUSION OF WARRANTIES: To the full extent permitted by law and except for the express warranties made herein, Les Schwab expressly excludes all warranties with respect to the farm tire, express or implied, including but not limited to the warranty of merchantability, the warranty of fitness for a particular purpose, and any warranties that may have arisen or may arise from course of performance, course of dealing, or usage of trade. This Limited Warranty gives you specific legal rights and you may have other rights that vary from state to state.
